# **Executive Summary**

Martinelli Farms is a 66 acre reserve committed to our natural world. Located in Foster, RI, nestled within approximately 300 acres of protected land and designed with all of the outdoor activities you and your family would want to enjoy. Members/owners can take advantage of fishing and hunting,organic farming, a art studio/workshop and a communal lodge to socialize with other like-minded members.

You are part member/owner of Martinelli Farms, with exclusive rights and use to a 1/8 acre piece of land. On your exclusive land, you have the freedom to comfortably camp, park your air-stream/trailer/mobile tiny house, or set up a temporary outdoor structure or primitive structure under the forest canopy. Most importantly, you have the ability to make it a home. Members / Owners will enjoy unfettered access to a grand lodge, a well-appointed art studio/workshop, communal BBQs, bike and hiking trails, outdoor fire pits a smoke house, horse stables within a working barn, and much more. Martinelli Farms will be powered by a solar system conveniently located near the Grand Lodge and art studio/workshop. Members/Owners will be able to use power and electric car charging stations when needed.

# What is "Martinelli Farms"?

Martinelli Farms consists of like-minded members, committed to sustainability by living "off the grid." Members/owners can partake in subsistence style living by growing mushrooms, cabbage, carrots, cucumber, spinach, kale, parsley and berries to jam. The land will also be plentiful with turkeys, geese and other animals for harvesting to help improve our ecosystem. Streams running through the property will be stocked with trout to catch and release or smoke.



Martinelli Farm members/owners are survivalists, campers, outdoor lovers, those who want to live off grid, families, adventure seekers and more. Consider Martinelli Farms an escape, a place to gather with your family and friends, and a place to indulge in your interests as it relates to our natural world.



Take time out to go for a run, enjoy subsistence fishing, make a table in the workshop, paint in the art studio, or preserve and package the produce and protein that you harvested. Members/Owners have the option to learn and be involved in many different activities, that can help generate a profitable income for you and the farm if you sell any produce/products or from the labor that needs to be done on the farm. Alternatively, members/ owners can also choose to do nothing at all but enjoy the outdoors.

Hunt Zone Instructors and professionals will be scheduling specific times in designated areas to learn and take part in the lifestyle of subsistence living. This will include: basic hunting skills; scheduled monthly hunts for birds and small game only; education on dressing the game after each hunt; basic survival techniques and much more. Other educated harvesters and cultivators will share their knowledge on the forestry farming business.

If you are looking for something sweeter to take part in, Martinelli Farms will have a Sugar Shed, Honey Hut and Winery on the property. Members/Owners can learn about the sugar cane crushing process, or get sticky harvesting honey or maple syrup.

In addition to wine tasting, and depending on the time of year, you can be involved in plucking some grapes and producing wine. Experts can explain how wine is made, where grapes were grown and what to expect during the process.



At Martinelli Farms all members/owners have the choice to learn and take part in these activities or do nothing at all but enjoy the outdoors and what nature has to offer.

Martinelli Farms began as a vision by Vito Martinelli. As a native "Rhodi", Vito has always been an avid outdoorsman. Martinelli Farms is the culmination of a lifetime of wanting to give back to the natural world, provide a safe haven for other outdoors people and bring the "Farm to Table" concept to life. 

Water logged areas, used for cultivation of crops for harvesting, filled with mushrooms and plentiful berries




# **Primary Map**

# The Investment Opportunity

Martinelli Farms is member owned, governed and managed outdoorsman retreat. It is 66 acres located in Foster, RI, surrounded by more than 300 acres of protected, unbuildable and/or inhabitable land and abundant wildlife including small game and seasonal birds.

As of March 2022 Martinelli Farms has the following assets to offer its members/owners that secure their investment:

- Deed to the property that has no mortgage; It was paid in full.
- **Total stock options are 230. Available for purchase is 180 exclusive stock options.**
- Our estimate as of March 2022 which has the land valued at a minimum of \$425,000. (After the completion of the access road will be a minimum of \$850,000)
- Government Farm Aid Contract: \$47,000 for access road.
- Our estimate in uncut trees, minimum \$50,000, will be processed into lumber and hobby wood. It will then be used to make furniture such as chairs, tables, frames and many other wooden merchandise. At that point, our estimate of processed assets will be at least \$250,000.
- Research, development and marketing assets needed to share with potential investors and Member/Owners. Investment made for this \$20,000.

We are seeking to raise a total of \$1.5MM in this "Charter Member/Owner Phase One" offering.

Phase One is the opportunity to become a member/owner of Martinelli Farms and gain exclusive rights and use of up to 60 1/8 acres for \$25,000 each to use and "live" in a non fixed based shelter of your choice. The appreciation value on each unit over a ten year period is estimated to be approximately 15% plus per annum. This could also be used as a rental property for supplemental income.

Additionally you can make more income by selling the product you have produced on the farm. This will be based on an approximate 70/30% split meaning, 70% going to you and 30% going to Martinelli Farms depending on the profit

The Phase One Charter Member/Ownership price will be \$25,000 per share. These members will be considered Preferred Series A shareholders. Preferred Series A shareholders will be afforded an additional 5% dividend preference on a pro-rata basis for the underlying Martinelli Farms LLC.

The company intends to provide semi-annual dividends of 10% of the net income free cash flow to all of its shareholders on a pro rata basis against annual membership dues. Annual membership dues will be determined based on the number of members/owners.

Preferred Series A shareholders will be afforded an annual total of 15% net dividends on a pro-rata basis. The remaining Series B and C shareholders will be afforded an annual total of 10% net dividends on a pro-rata basis. The remaining percentage of net income will be used for operating Martinelli Farms and ongoing improvements.

Charter Members/Owners and their guests will have priority access to all of the properties amenities, facilities, activities and events. Member/Ownerships purchased in phase two will be a \$50,000 minimum per share. After project completion, the remaining member/ownerships will be a \$75,000 minimum per share.

### Phase One "Completion" Amenities will include:

- A main private access road to shared structures
- Dedicated trails and paths to member units
- A Grand Lodge, with many amenities
- The build out of Barn with approx 10 horse stables (first come, first serve basis, additional dues will apply)
- Art Studio/Workshop
- Caretaker's Abode

- Dedicated land to harvest for birds and small game
- Stocked streams for fishing
- 23 Trails for hiking
- Greenhouses and Acreage for farming
- 2 acres of open fields to grow crops
- 10 acres to grow berries and mushrooms under forestry canopy
- 6 acres open field for bird harvesting and recreation

### **Timeline for Phase One:**

- Q2 includes build out of private access road and trails that lead to your exclusive piece of land
- Q2-Q3 start plans and construction on the Grand Lodge, the barn, the caretaker's abode, and the workshop
- Q3 clearing and set up of multi-land use for trails
- Q4 Completion of Grand Lodge and Barn, allowance of farming and hunting


